1. I Atul Sharma, S/o Mr. Ram Chandra Sharma aged 51 years working as Vice President-Site Head with Jubilant Infrastructure Limited having its registered address: Plot-1A Sector 16-A, Noida, Gautam Buddha Nagar, Uttar Pradesh, 201301 do hereby solemnly affirm and state as follow:
2. I am representative of Jubilant Infrastructure Limited, Bharuch unit (JIL) and I am duly authorized to make this affidavit.
3. This is to certify that, as per GERC order dated 3 August, 2023, M/s. Jubilant Infrastructure Limited has executed the following Power Purchase Agreements:
 - a. Power Purchase Agreement with PCBL, dated August 17, 2023 for 4 MW power
 - b. Power Purchase Agreement with PTC, dated July 26, 2023 for procurement of power through the power exchanges
 - c. Power Purchase Agreement with DGVCL, dated July 18, 2023 for procurement of 8 MW power
4. It is submitted that the Articles/provisions of the abovementioned PPAs executed are as per the directions of the Hon'ble GERC in its order mentioned above, provisions of the Act, Rules, bidding guidelines and deviations approved by the Commission from time to time and that there are no other deviations undergone by the JIL in the bidding documents other than those earlier approved by the Commission, except in Sr. No. 9 of the Table under Clause 3 (Delayed Payment charges) of the PPA with DGVCL.
5. It is also submitted that JIL, vide its letter dated August 21, 2023 has requested DGVCL to make suitable amendment to the PPA dated July 18, 2023 as per the directives of the Hon'ble Commission. The amendment to the said PPA with DGVCL shall be submitted to the Hon'ble Commission in due course of time.
