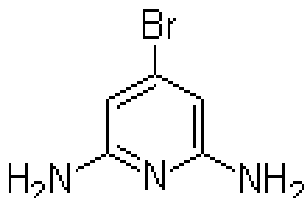

#### SECTION 4: First aid measures

##### 4.1. Description of first aid measures

#### 4.2. Most important symptoms and effects, both acute and delayed

##### Acute effects:

- **Eyes:** Causes serious eye irritation. More than ordinary care should be used to prevent eye contact.

#### 5.2. Special hazards arising from the substance or mixture.

- Toxic vapors may be released on thermal decomposition including nitrogen oxides, carbon monoxide carbon di-oxide, Hydrogen bromide gas and irritating and toxic fumes.

#### 5.3. Advice for firefighters
